II. ENVIRONMENTAL JUSTICE DATA:

Trump administration pulled federal websites tracking shifts in the **climate**, pollution and **extreme weather** impacts on low-income communities, and identifying pieces of infrastructure that are extremely vulnerable to climate disasters. These are tax-payer funded datasets about communities' exposure to harmful pollution and data that helps local governments build resilience to extreme weather events.

Also cut was: funding to provide gender appropriate housing for incarcerated transgender individuals and nearly \$700,000 to study the efficacy of LGBTQ liaisons in local police departments. The Boston-based Community Resources for Justice lost nearly \$37 million, some of which supported crime data analysis and other services to local governments. The National Center for Victims of Crimes saw \$2 million in funding cut off for a website it operates called VictimConnect, which directs victims to support services.

VI. NATIONAL PARKS

1. A large image of and a quote from Harriet Tubman, about her experience coordinating the clandestine network for slaves seeking freedom, have been removed from a National Park Service webpage about the Underground Railroad.
2. Pages for historic sites related to the internment of Japanese Americans and the Stonewall Uprising for gay rights.
3. The National Park Service removed references to transgender people from an article by historian Wendy Rouse titled "The Very Queer History of the Suffragist Movement" as part of the agency's commemoration of the movement. When Rouse requested that the original version of her article be restored, the Park Service took it down.

VII. TREASURY DEPT.

1. Among the sites taken down was a page dedicated to the Inaugural Treasury Advisory Committee on Racial Equity
2. More than 25 pages from the Internal Revenue Service, including the transcript of a video titled "Here's how to avoid I.R.S. penalties and interest" and the form private schools must submit annually to certify that they have not engaged in racially discriminatory behavior.

VIII. DEPT. OF EDUCATION

1. The Education Department announced it had removed or archived hundreds of guidance documents, reports and training materials. The department said it cancelled contracts totaling more than \$2.6 million for staff DEI training.
2. Included in the removal were: "Resources for LGBTQI+ Students," an overview of civil rights laws related to "Race, Color, or National Origin Discrimination," and guidance titled "Avoid the Discriminatory Use of Artificial Intelligence."
3. The Equity Action Plan.
4. The department's Office for Civil Rights announced it dismissed 11 complaints alleging book bans had created a hostile environment for kids. The department said the complaints

over restrictions on titles about race or LGBTQ+ issues were meritless. The office also rescinded all guidance that framed book bans as a violation of civil rights laws.

5. Dissolution of the Department's Diversity & Inclusion Council

IX. DEPT. OF DEFENSE

1. Defense Secretary Pete Hegseth ordered the military to immediately stop recognizing identity months including: Black History Month, Women's History Month, Asian American and Pacific Islander Heritage Month, National Hispanic Heritage Month, National Disability Employment Awareness Month, and National American Indian Heritage Month.
2. The U.S. Air Force deleted a biography of the first woman in [United States Air Force Thunderbirds](#) demonstration squadron, retired colonel [Nicole Malachowski](#).
3. The [U.S. Marine Corps](#) deleted an article about the first Black Marine, technical sergeant [Alfred Masters](#), who joined the service in 1942 for the [Pacific War](#) (1941–45).
4. The Department of Defense deleted a profile of the first-ever black Medal of Honor winner, Sergeant [William Carney](#) of the [54th Massachusetts Colored Infantry](#), as prohibited DEI content.
5. A photograph of Medal of Honor recipient [Harold Gonsalves](#) was removed.
6. A page about the highly decorated [442nd Infantry Regiment](#), a segregated Japanese-American unit, was removed.^[19] Following a statement of concern by Hawaii Congressman [Ed Case](#), the page was restored on March 14.^[20] According to the Japanese-American internment archive and history group Denshō, the regiment is now labeled a "key military unit" and any mention of the race or place of origin of its soldiers and officers has been removed.^[21] Denshō executive director Naomi Ostwald Kawamura noted in a statement, "The irony of this revisionist approach is that the 442nd Regimental Combat Team only existed because of race...the government recognized that a Japanese American unit could counter [Axis](#) propaganda about [U.S. racism](#) and provide a strategic tool for American war efforts by demonstrating America's supposed racial tolerance to the rest of the world. This means that the racial framing of the 442nd is not an incidental part of the story, it is the story. Removing explicit references to race and identity erases the very conditions that led to the unit's formation.
7. A profile of a 173rd Sky Soldiers paratrooper of Navajo heritage was deleted.

8. A profile of Brigadier General Doug Lowrey that mentioned his ancestors' survival of the [Cherokee removal](#) was deleted.
9. A history of indigenous women fighting in wars throughout American history was deleted.
10. A news release about a guardsman from South Dakota Army National Guard's 235th Military Police Company receiving a dress-protocol exemption based on his [Oglala Sioux](#) heritage was deleted.
11. A profile of [Medgar Evers](#), a veteran of World War II and an assassinated leader of the American [civil rights movement](#), was deleted from the [Arlington National Cemetery](#) website.
12. Arlington removed links to three modules from the Notable Graves menu of their website (African American History, Hispanic American History, Women's History), links to five modules from Education Themes sections (Civil War, Environment, Medal of Honor, Service Branches, Women's History), and links to two modules on the History of Arlington National Cemetery (Freedman's Village, Section 27).
13. A profile of [Ira Hayes](#), an enrolled member of the [Gila River Indian Community](#) who was among those [raising the American flag at Iwo Jima](#), was deleted.
14. Content about female fighter pilots was deleted.
15. Pages on [Colin Powell](#), the first African American chairman of the [Joint Chiefs of Staff](#), were deleted.
16. A section of Arlington National Cemetery's website on notable graves of Hispanic Americans, including Jose Hector Santa Ana, a great-great-nephew of Mexican General [Antonio López de Santa Anna](#), was removed.
17. An article about actress [Bea Arthur](#)'s time in the Marines during World War II was removed.
18. Articles related to the [Holocaust](#) were removed, including one about a cadet's experience visiting [concentration camps](#), an article about survivor Kitty Saks, and a page that commemorated Holocaust Remembrance Week.
19. Pages about [Lisa Jaster](#), the first female Army Reserve graduate of [Ranger School](#), and [Jeannie Leavitt](#), the first female fighter pilot, were removed. An article about the [Women Airforce Service Pilots](#) was also removed.
20. Pages sharing details about [Saleha Jabeen](#), the first Muslim woman chaplain in the United States Air Force, and [Khady Ndiaye](#), the first Muslim woman chaplain candidate in the United States Army were deleted and replaced with 404 notices.

XIII. STATE DEPARTMENT

1. removed the X gender marker and replaced “gender” with “sex” on online consular forms. A page with tips for lesbian, gay, bisexual, transgender, queer and intersex travelers was altered. It’s now titled “[LGB](#)Travelers” instead of “[LGBTQIA](#)+ Travelers.”

1. Almost 50 research papers from the **Office of Scientific and Technical Information**. The removed papers span multiple fields, including optics, chemistry and experimental medicine.

1. 20 web pages from the [National Institute of Standards and Technology](#), including a [page](#) detailing the organization’s zero tolerance harassment policy.
2. 18 pages from the [U.S. Patent and Trademark Office](#), including pages about [veterans](#)’ innovation and entrepreneurship and a [program](#) to teach high schoolers about intellectual property.

MISCELLANEOUS

1. Content and datasets essential for research, policy making, transparency, and accountability began to disappear from US government websites beginning late Friday, January 31.
2. Deleted datasets "disproportionately" come from environmental science agencies like the Department of Energy, National Oceanic and Atmospheric Administration (NOAA), and the Environmental Protection Agency (EPA)

3. Office of Gun Violence Prevention
4. Pages related to the history of women in the military, a decorated Japanese American Army unit, and Navajo Code Talkers were taken down.
5. Many agencies removed references to transgender people, including the CDC, the National Park Service, the State Department, and the Social Security Administration, according to NPR
6. Across the federal government, agencies have been busy scrubbing photographic and written references about women, people of color and members of the LGBTQ+ community from their websites.
7. The Trump administration has moved to take down COVID-19 signage from federal agencies and replace websites that had previously offered health information and access to tests and treatment for the virus, swapping them out with a page titled "Lab Leak: The True Origins of COVID-19" published by the White House. For the past two years, the Department of Health and Human Services had run the COVID.gov and COVIDTests.gov websites to link to resources about the virus, like finding vaccines and ordering free tests offered during the winter. Those HHS websites have now been replaced, redirecting to the White House page, which cites information from the Republican-led Select Subcommittee on the Coronavirus Pandemic's report last year.
8. In a bureaucratic bombshell, Director of National Intelligence John Ratcliffe has asked the White House to rescind a ten-year-old executive order that required a uniform policy for marking and handling "controlled unclassified information" (CUI).
9. Four pages from the Nuclear Regulatory Commission, including an outline of the organization's equal employment opportunity programs and diversity initiatives.
10. During Trump's first administration, 26% of US government websites with terms like "climate change", "clean energy" and "adaptation" went dark.
11. Thousands of URLs for thousands of datasets in all areas of science now lead only to the '404 Error'.
12. Other data that has disappeared from US government websites includes the National Ocean and Atmospheric Agency's Climate Data.
13. People applying for grants and certificates using the U.S. Small Business Administration's website used to see a photograph of a group of people of varying ages, genders, and skin tones smiling in front of a white board. The SBA removed the image from its website.
